PUBLIC NOTICE CITY OF FRUITLAND CITY COUNCIL ELECTION

Notice is hereby given that the City of Fruitland will hold a **General Election for Three (3)** seats on the Fruitland City Council on Monday, October 1, 2018. Polling will take place at City Hall, 401 East Main Street, from 7:00 a.m. to 7:00 p.m. The seats currently held by Councilor Darlene Kerr, Councilor Roland H. Palmer and Councilor Charles Nichols will be subject to election. Also the City will be holding a **Special Election for One (1)** seat at the same time. The seat currently held by Councilor Gloria J. Ortiz will be **subject to election for the term of two (2) years.** The other three seats are for four (4) years.

The following Election Schedule has been established for the conduct of the election:

- * Monday, July 9, 2018: Candidates may file Petitions of Candidacy with the members of the Board of Supervisors of Elections
- * Monday, August 27, 2018: Deadline for filing Petitions of Candidacy is 4:30 p.m.
- * Monday, September 10, 2018: Deadline to withdraw from Candidacy is 4:30 p.m.
- * Monday, September 17, 2018: Deadline for qualified residents to register to vote in 2018 Fruitland City Council Election is 4:30 p.m.
- * Sunday, September 23, 2018: Notice of Election will be posted in *The Daily Times* and on the City Website at www.cityoffruitland.com.
- * Sunday, September 30, 2018: Sample ballot will be published in *The Daily Times* and on the City Website at www.cityoffruitland.com.
- * Monday, October 1, 2018: Election Day at City Hall. 7:00 a.m. to 7:00 p.m.
- * Tuesday, October 9, 2018: Newly elected Councilors will be inducted into Office by the City Clerk.
